- My great aunts Isabel and Keturah Baldwin of Beach Lake penned the book *Your Heritage in Beach Lake*, which can be viewed at the Wayne County Historical Society.
- My husband, Michael Rollison and I live in Damascus Township, with our dog Ruby.

WHEN: General Election: Tues November 5th. Polls are open from 7:00 am - 8:00 pm.

- October 7 is the last day to register before this year's November election. You can obtain an application at the Wayne County Courthouse in the Elections Office, or register online at www.pavoterservices.pa.gov. You can also check your registration on this website, change your registration and look up your polling address.
- Civilian absentee ballots are open from Sept 16 – October 29. They can be obtained from the Wayne County Courthouse.
- Last Day for County Boards of Elections to Receive Voted Civilian Absentee Ballots: November 1
- Last Day for County Board of Elections to Receive Voted Military and Overseas Absentee Ballots (Submitted for Delivery No Later Than 11:59 p.m. on November 5): November 12

VOTER ELIGIBILITY: You must be a US Citizen (for at least 1 month prior to the election); you must be a resident of PA and your election district for at least 30 days prior to the elections; you must be at least 18 years of age on the day of the election.
